

#### HAZARDOUS SUBSTANCE CONTAMINATED VEHICLE

The jurisdiction has determined that the vehicle has been contaminated by a 'hazardous substance' and is unsafe for use. Excluding flood damaged vehicles. A 'hazardous substance' is any substance that could diminish the safety of the vehicle or cause injury to its occupants. The 'hazardous substance' has one or more, but is not limited to the following intrinsic 'hazardous properties': Explosiveness, Flammability, Ability to oxidize (accelerate a fire), Human toxicity (acute or chronic), Corrosiveness (to human tissue or metal), Eco toxicity (with or without bioaccumulation), Capacity, on contact with air or water, to develop one or more of the above properties.

JUNK

The vehicle is incapable of safe operation for use on the roads or highways and has no resale value except as a source of parts or scrap, or the vehicle's owner has irreversibly designated the vehicle as a source of parts or scrap. ### MANUFACTURER BUY BACK

A vehicle that has been bought back by the manufacturer under jurisdictiondefined regulations or laws, such as lemon laws. For example, the manufacturer could be obligated to buy back the vehicle when a specified number of repair attempts fails to correct a major problem on a new vehicle, or if a new vehicle has been out of service for repair for the same problem for a cumulative period of 30 days or more, within one year of purchase.

# SALVAGE: DAMAGED OR NOT SPECIFIED

Any vehicle which has been wrecked, destroyed or damaged, to the extent that the total estimated or actual cost of parts and labor to rebuild or reconstruct the vehicle to its preaccident condition and for legal operation on roads or highways exceeds a jurisdiction defined percentage of the retail value of the vehicle. The retail value of the vehicle is determined by a current edition of a nationally recognized compilation (to include automated data bases) of retail values. Salvage--Damage or Not Specified also includes any vehicle to which an insurance company acquires owner-ship pursuant to a damage settlement, or any vehicle that the vehicle's owner may wish to designate as a salvage vehicle by obtaining a salvage title, without regard to extent of the vehicle's damage and repairs, or any vehicle for which the jurisdiction cannot distinguish the reason the vehicle was designated salvage.

# SALVAGE: REASONS OTHER THAN DAMAGE OR STOLEN

Any vehicle the reporting jurisdiction considers salvage based on criteria, such as abandonment, not covered by the Salvage-- Damage or Not Specified and Salvage--Stolen brands. Note.--Percent of damage is not reported with brand code 50. **Clean Records Found**

# **GLOSSARY**

**MAKE** is the manufacturer's brand name.

**MODEL** is the manufacturer designation of the lot.

YEAR is the manufacturer's designated model year.

**BODYSTYLE** is the manufacturer's designation of vehicle configuration.

**COLOR** is the common color name that reasonably represented the exterior color of the vehicle. COLOR is not the manufacturer's designated color name, but rather simply a general descriptive name.

CYLINDERS is the manufacturer's designation of the vehicle's power train

**FUEL** designated the fuel type used by the engine as designated by the VIN

**DRIVE** is the manufacturer's designation of the vehicle's power train

ENGINE is the motor specification denoted by the VIN of the vehicle

**ODOMETER** codes are shown to reflect the known reliability of the odometer reading.

## **NMVTIS Consumer Access Product Disclaimer**



NMVTIS Consumer Access Product DisclaimerThe National Motor Vehicle Title Information System (NMVTIS) is an electronic system that contains information on certainautomobiles titled in the United States. NMVTIS is intended to serve as a reliable source of title and <u>brand</u> history forautomobiles, but it does not contain detailed information regarding a vehicle's repair history

All states, insurance companies, and junk and salvage yards are required by federal law to regularly report information toNMVTIS. However, NMVTIS does not contain information on all motor vehicles in the United States because <u>some states</u> are not yet providing their vehicle data to the system. Currently, the data provided to NMVTIS by states is provided in avariety of time frames; while some states report and update NMVTIS data in "real-time" (as title transactions occur), otherstates send updates less frequently, such as once every 24 hours or within a period of days.

Information on previous, significant vehicle damage may not be included in the system if the vehicle was neverdetermined by an insurance company (or other appropriate entity) to be a "total loss" or branded by a state titling agency.Conversely, an insurance carrier may be required to report a "total loss" even if the vehicle's titling-state has notdetermined the vehicle to be "salvage" or "junk."

A vehicle history report is NOT a substitute for an independent vehicle inspection. Before making a decision to purchase avehicle, consumers are **strongly encouraged to also obtain an independent vehicle inspection** to ensure the vehicledoes not have hidden damage. The <u>Approved NMVTIS Data Providers</u> (look for the NMVTIS logo) can include vehiclecondition data from sources other than NMVTIS.

NMVTIS data **INCLUDES** (as available by those entities required to report to the System):

Information from participating state motor vehicle titling agencies.

Information on automobiles, buses, trucks, motorcycles, recreational vehicles, motor homes, and tractors. NMVTISmay not currently include commercial vehicles if those vehicles are not included in a state's primary database fortitle records (in some states, those vehicles are managed by a separate state agency), although these records maybe added at a later time.

Information on "brands" applied to vehicles provided by participating state motor vehicle titling agencies. Brandtypes and definitions vary by state, but may provide useful information about the condition or prior use of thevehicle.

Most recent odometer reading in the state's title record.

Information from insurance companies, and auto recyclers, including junk and salvage yards, that is required bylaw to be reported to the system, beginning March 31, 2009. This information will include if the vehicle wasdetermined to be a "total loss" by an insurance carrier.

Information from junk and salvage yards receiving a "cash for clunker" vehicle traded-in under the ConsumerAssistance to Recycle and Save Act of 2009 (CARS) Program.

Consumers are advised to visit <u>vehiclehistory.bja.ojp.gov</u> for details on how to interpret the information in the system and understand the meaning of various labels applied to vehicles by the participating state motor vehicle titling agencies.
